


Details of last three year's net profit computed as per Section 198 of the Act is as under :

Average Annual Profit for the financial year ended on 31/03/2022 is **Rs.13,55,37,816/-** and as per the provisions of Section 135 of the Act, the Company is required to spent **Rs.27,10,756/-** (2% of Average Annual Profit for the financial year ended on 31/03/2022 as calculated under Section 198 of the Act) on CSR activities during the financial year 2022-2023.

The Company proposes to spend **Rs.27,10,756/-** as CSR expenditure during the financial year 2022-2023. The Board Directors at its meeting held on 08/04/2022 has approved the action plan for FY 2022-2023 towards CSR Activities in pursuance of Company's CSR Policy.
